- (vii) where the land has been granted for more than one purpose viz. residential, commercial and industrial, the valuation in such a case shall be the mean or average of the prescribed values;
- (viii)a flat means the covered residential tenement having separate property unit number or sub- property unit number;
- (ix) in residential, multistory building, additional storey shall be charged if it consists of bed room and bath room; and
