## Notification

**S.R.O. 1716 (I)/2024-** In exercise of powers conferred by sub-section (4) of section 68 of the Income Tax Ordinance, 2001 (XLIX of 2001) and in suppression of tis notification No. S.R.O.1547 (1)/2021, dated the  $1^{st}$  December, 2021 Federal Board of Revenue is pleased to determine the following fair market value of immovable properties in columns (2) to (8) of the Table below, in respect of areas or categories of MirpusKhas, as specified in Appendix-I thereof, namely:-

- (ii) value is per square yard of the covered area of ground floor plus covered area for the additional floors;
- (iii) the value in respect of commercial property consisting of more than one storey shall be increased by 25% for each additional storey i.e. value of each storey other than ground floor shall be calculated @ 25% of the value of the ground floor;
- (iv) built up industrial property value is per square yard of the entire plot area plus covered area of the plot per square yard;
- (v) the value in respect of a residential building consisting of more than one storey shall be increased by 25% for each additional storey i.e. value of each storey other than ground floor shall be calculated @ 25% of the value of the ground floor;
- (vi) a property which does not appear to fall in any of the categories shown in the below Appendix shall be deemed to fall in the adjacent lowest category of the Appendix-I;
- (vii) where the land has been granted for more than one purpose viz. residential, commercial and industrial, the valuation in such a case shall be the mean or average of the prescribed values;
- (viii) a flat means the covered residential tenement having separate property unit number or sub- property unit number;
- (ix) in residential, multistory building, additional storey shall be charged if it consists of bed room and bath room; and
- (x) area-wise categories are prescribed in the following Appendix-I: -
